B. ADMISSION REQUIREMENTS FOR ADELPHI UNIVERSITY

Borough of Manhattan Community College (BMCC) graduates are required to meet the minimum criteria for admission to Adelphi University. At this time, the University requires a grade point average (GPA) of 2.3 based upon a maximum GPA of 4.0.

Applicants whose GPA falls below a 2.3 but above a 2.0 will be given individual consideration on a case-by-case basis.

Students with educational experiences at institutions in addition to BMCC will be considered on a case-by-case basis. Students with an affirmative response to the application questions related to prior academic dismissal or criminal activity will be reviewed on a case-by-case basis, and in consultation with the Dean of Student Affairs. An affirmative response will not automatically prevent admission, but any omission or falsification is grounds for denial or rescission of admission, or expulsion.

To prepare BMCC students to meet with departmental advisors who will determine which courses they will need to fulfill their bachelor's requirements, students may meet with counselors in the admissions office to identify which requirements have been completed. Students may also engage the online Transfer Evaluation System (TES) <http://admissions.adelphi.edu/transfer/transfer-credits.php> to access course equivalencies and determine how they will transfer to AU.

C. TRANSFER CREDIT AWARDED

F. ARTICULATION AGREEMENT FOLLOW-UP PROCEDURES

1. Procedures for reviewing, updating, modifying or terminating agreement:

When either of the degree programs involved in this agreement undergoes a change, the agreement will be reviewed and revised accordingly by representatives from each institution's respective departments, selected by their chairpersons/program director.

2. Procedures for evaluating agreement, i.e., tracking the number of students who transfer under the articulation agreement and their success:

Each semester Adelphi University will provide BMCC with the following information: a) the number of BMCC students who applied to the program; b) the number of BMCC students who were accepted into the program; c) the number of BMCC students who enrolled; and d) the aggregate GPA of these enrolled students.

3. Sending and receiving college procedures for publicizing agreement, e.g., college catalogs, transfer advisers, Websites, etc.:

Adelphi University and BMCC agree to cooperate in communicating with each other and with their respective constituents about the relationship between the two institutions. Faculty and staff at both institutions will share the information provided in this agreement with interested and qualified students. Adelphi University and BMCC agree to provide counseling and advisement to students and prospective students about this partnership and the inherent benefits.

BMCC will promote Adelphi University in any publications and/or websites that discuss transfer options and agreements. BMCC will also distribute and make available any appropriate Adelphi University printed materials.

An administrator from Adelphi University will implement this agreement at Adelphi University and communicate changes to those parties to whom the information is pertinent. The same will be true at BMCC.

G. Additional Information (e.g., financial aid, transfer scholarships):

New transfer students are automatically considered for merit-based scholarships upon their acceptance to the University; a separate application is not required to be considered for most Adelphi merit scholarships. Eligible students will receive a Scholarship Letter from the Admissions Office notifying them of their eligibility. Awards are renewed each year subject to the terms and conditions outlined under each award.

To ensure maximum eligibility for other sources of financial aid, applicants are encouraged to file the FAFSA as soon as possible after October 1, but no later than the priority deadline. After filing the FAFSA, the student will receive a Financial Plan Summary detailing their financial aid awards. A letter will be sent to the student if additional information is required to determine their eligibility for need based funding. All requested documentation must be submitted as soon as possible to ensure receipt of limited funds.

The Adelphi University Transfer Scholarship for Full-Time Study is offered to new, full-time students who demonstrate high academic achievement. For new transfers initial criteria includes a cumulative transfer GPA of at least 3.0.

Award amounts are dependent upon the individual's academic profile and start at \$9,000 per year.

The **Adelphi University Phi Theta Kappa Award** for full-time students is offered to new, full-time transfer students who demonstrate high academic achievement. For new transfers, criteria include a transfer GPA of at least 3.0 and proof of Phi Theta Kappa membership. The **Adelphi University Phi Theta Kappa Select Award** for full-time students is offered to new, full-time transfer students who demonstrate high academic achievement and a commitment to service in the

community. For new transfers, the initial criteria include a transfer GPA of at least 3.3 and proof of Phi Theta Kappa membership. **The Adelphi University Tau Sigma Award** for full-time students is offered to current, full-time transfer students who have been a member of Tau Sigma for a minimum of one semester. These individuals must demonstrate continued high academic achievement and a commitment to service in the community and Tau Sigma. Initial criteria includes an Adelphi University GPA of at least 3.5 and proof of Tau Sigma membership.

BMCC students who are accepted and enroll full-time directly into Adelphi University's MBA program immediately following graduation from Adelphi's undergraduate business program, who have received an undergraduate scholarship and maintained the scholarship's terms and conditions, may continue to receive their undergraduate academic scholarship for up to a maximum of one half of the full-time tuition for the graduate year of Business.

Borough of Manhattan Community College students who have been admitted to Adelphi University and have paid their tuition deposit will be permitted to register during early registration at the same time as their Adelphi University counterparts.

Effective Date: Fall 2017

This agreement becomes effective on the date of signature by representatives of the institutions reflected below, and may be renewed annually, by mutual consent and agreement. It may be modified or terminated at any time by either institution with written notification and by mutual consent. In the event it is decided at any time to modify or terminate this agreement, commitments made to individual students already in the program will continue in effect for the terms applicable at the time the student enrolled in the program.
